➤ **Consideration and Possible Approval of Resolution regarding Veterans Transportation Services.**

Discussion, consideration, and possible approval of a resolution regarding the **preservation, continuity, and protection of transportation services for Carroll County veterans**, including the Commission's position concerning:

- Preservation and continuation of the existing veterans transportation program. Potential transfer, discontinuation, or restructuring of veterans transportation services.
- Protection against a reduction or interruption in transportation services available to Carroll County veterans.
- Development and evaluation of contingency plans and alternative transportation arrangements.
- Authorization for appropriate Commission representatives to communicate and advocate regarding veterans transportation services.
